WRITE YOUR EXPORT PLAN</b></p> <p><i>A roadmap to success and a tool to measure your business' progress.</i></p>  | <p>An export plan is a business plan that focuses on international markets. REGULATIONS AND PERMITS</b></p>   | <p>Visit the Foreign Affairs and International Trade to find out if your goods require an export permit: <a href="http://www.international.gc.ca">www.international.gc.ca</a></p> <p>Find out if your goods are regulated by a government department and agency: <a href="http://sbbc.co/regulatedgoods">sbbc.co/regulatedgoods</a></p>   | <input type="checkbox"/> |
| <p><b>5. PRODUCT AND LABELLING REQUIREMENTS</b></p>  | <p>Different government departments will have different labeling standards depending on industry of your product. Contact the relevant government of the foreign country or ask your buyer to give you information about the labeling requirement.</p>  | <input type="checkbox"/> |
| <p><b>6. TARIFF CLASSIFICATION (HS CODE)</b></p>   | <p>Find the Tariff classification (HS code), Tariff Treatment, duties, taxes of your goods.</p> <p>Determine the 8 digit tariff classification number (HS code) for each item exported. Call Statistics Canada 1-800-257-2434 to obtain codes. Your buyer or international Freight Forwarder can provide you, for a fee, with the HS code.</p>  | <input type="checkbox"/> |

<b>7. OBTAIN A CERTIFICATE OF ORIGIN</b>	<p><b>Under the free trade agreements:</b></p> <ul style="list-style-type: none"> <li>Value shipment less than CAD\$2500: a formal certificate of origin is not required, only a letter stating the origin of the goods</li> <li>Value shipment greater than CAD\$2500: a formal certificate of origin required: <a href="http://sbbc.co/certorigin">sbbc.co/certorigin</a></li> </ul> <p><b>Under GPT and LDCT:</b> <a href="http://sbbc.co/gptldct">sbbc.co/gptldct</a></p>	<input type="checkbox"/>
<b>8. REGISTER YOUR BUSINESS</b>	<p>Apply for a business name and register a sole proprietorship, partnership or a corporation: <a href="http://sbbc.co/registerbusiness">sbbc.co/registerbusiness</a></p> <p>See our <a href="#">Registration Services</a> for help.</p>	<input type="checkbox"/>
<b>9. OBTAIN IMPORT/EXPORT ACCOUNT</b>	<p>Obtain an import/export account, from Canada Revenue Agency at 1-800-959-5525 or <a href="http://www.cra-arc.gc.ca">www.cra-arc.gc.ca</a>.</p> <p>Small Business BC offers several import and export <a href="#">advisory services</a>.</p>	<input type="checkbox"/>
<b>10. ## STAGE 2: AT THE BORDER

<b>11. EXPORT DECLARATION B13A</b>  <i>Not required for shipments to US or shipments valued under \$2000.</i>	<p>Use the Canadian Automated Export Declaration to file the B13A form at least 48 hours prior to export. Visit <a href="http://sbbc.co/exportdeclaration">sbbc.co/exportdeclaration</a> to download the free software, or call 1-800-257-2434.</p>	<input type="checkbox"/>
<b>12. ACCOUNTING PACKAGE DOCUMENTS</b>	<p>Customs require 3 copies of your completed B13A (if applicable), certificate of origin (if applicable), commercial invoice, and all required permits certificates or licenses for the destination.</p>	<input type="checkbox"/>
